This emergency meeting was called and held in accordance with LGC 551.045 subsection B (1), which states:

...

EXCEPTION TO GENERAL RULE: NOTICE OF EMERGENCY MEETING OR EMERGENCY ADDITION TO AGENDA. (a) In an emergency or when there is an urgent public necessity, the notice of a meeting to deliberate or take action on the emergency or urgent public necessity, or the supplemental notice to add the deliberation or taking of action on the emergency or urgent public necessity as an item to the agenda for a meeting for which notice has been posted in accordance with this subchapter, is sufficient if the notice or supplemental notice is posted for at least one hour before the meeting is convened.

(b) An emergency or an urgent public necessity exists only if immediate action is required of a governmental body because of: (1) an imminent threat to public health and safety.

...

Specifically, an emergency exists requiring immediate removal by vacuum of sludge and liquid from the work area at the wastewater treatment plant. If sludge is not removed, it could become hazardous and cause health and safety concerns. Immediate removal is needed to protect the public citizen's health and safety in Wills Point.

- 1) CONSIDER APPROVAL OF PROPOSAL FROM MAGNA FLOW ENVIRONMENTAL NOT TO EXCEED \$24,400 (REPLACING AUGUST 18, 2023 CITY COUNCIL APPROVAL OF ASC ENVIRONMENTAL SERVICES NOT TO EXCEED \$20,000) TO VACUUM AND REMOVE SLUDGE AND LIQUID FROM THE WORK AREA AT THE WASTEWATER TREATMENT PLANT OR \$34,400 TO REMOVE ALL SEPTIC SLUDGE FROM THE CLARIFIER, ESTIMATED AT 58,000 GALLONS
