This emergency meeting was called and held in accordance with LGC 551.045 subsection B (1), which states:

...

EXCEPTION TO GENERAL RULE: NOTICE OF EMERGENCY MEETING OR EMERGENCY ADDITION TO AGENDA. (a) In an emergency or when there is an urgent public necessity, the notice of a meeting to deliberate or take action on the emergency or urgent public necessity, or the supplemental notice to add the deliberation or taking of action on the emergency or urgent public necessity as an item to the agenda for a meeting for which notice has been posted in accordance with this subchapter, is sufficient if the notice or supplemental notice is posted for at least one hour before the meeting is convened.

(b) An emergency or an urgent public necessity exists only if immediate action is required of a governmental body because of: (1) an imminent threat to public health and safety.

...

Specifically, an emergency exists because a portion of the City's sanitary main sewer line has collapsed and is impacting a number of homes in the area of E. James Street and LyBrand Street. This requires immediate repairs/replacement to protect the public citizens' health and safety in Wills Point.

- 1) CONSIDER APPROVAL OF BID RECEIVED FROM CAPPS-CAPCO CONSTRUCTION, INC. NOT TO EXCEED \$18,705.00 TO BEGIN INVESTIGATING THE COLLAPSED SANITARY SEWER LINE LOCATED ON E. JAMES ST. AT LYBRAND ST., TO INCLUDE REPAIRS / REPLACEMENT, TRANSFER USING EXISTING CLEANOUT, PAVEMENT REPAIR AND MOBILIZATION
- 2) ADJOURN
